Who can benefit?

jobseekers or job changers employers

- Jobseekers or job changers aged 18+
- Nationals of an EU country, Norway or Iceland or long-term residents in these countries
- Interested in moving to another EU country for a job, traineeship or apprenticeship
 - minimum <u>6 months</u> for job offers or apprenticeship
 - minimum <u>3 months</u> for **traineeships**
- Regardless of their qualification level

- legally established companies in the EU countries, Norway and Iceland for financial benefit **only SMEs** (with a max. 250 employees)
- offering a written work contract of at least:
 - 6 months for jobs or apprenticeships
 - 3 months for traineeships.
- compliant with national law

jobseekers, employers or jobs in the UK, Liechtenstein, Switzerland and third countries are not eligible





Financial support

jobseekers or job changers

Interview trip	110€-385€ (depending on distance travelled) + DSA 55€/day	Recognition	flat rate up to 440€
Relocation & Family support	Up to 1.540€ (variable according to destination country)	Suplementary trip	flat rate up to 550€
Language training	Reimbursement of actual declared costs up to 2.200€	Traineeships	Subsistence allowance up to 660€/month (during max. 6 months)

not receive financial support from the employer, other project or authority for the same purpose





Financial support employers



Only for SMEs (up to 250 workers)



Financial support to deliver **integration training programmes *** (basic or comprehensive) to **recruited candidates**



flat rate, up to 2.000€ per recruited candidate

* **integration programme**: job-related training and/or language course (<u>basic</u>) combined with other post-placement supports such as administrative support and settlement assistance (<u>comprehensive</u>)





When to apply

Always apply before!

- \rightarrow the **interview trip**
- \rightarrow the beginning of the **language training**
- → the **relocation** & start of traineeship / apprenticeship / job
- → the **integration programme**

What 🔘 is Targeted Mobility Scheme?

- · It offers dedicated support from national employment services for people seeking work, training or apprenticeships in another EU country, Norway or Iceland.
- On a fair basis, it tackles the needs of jobseekers to remove mobility obstacles.
- It helps employers in these countries who are looking for motivated and qualified workers.
- Available support includes funding to cover things like language courses. getting your qualifications recognised, travel and subsistence expenses.

Who can apply?

- Jobseekers aged 18 and over.
- Nationals of an EU country, Norway or Iceland or anyone legally resident in these countries.
- Any jobseeker, regardless of their qualifications.

What is Targeted Mobility Scheme?

 It offers your business dedicated support from local employment services to recruit motivated and qualified jobseekers from other European countries for work, traineeship or apprenticeship.

 If you are a <u>small or medium-sized business</u>, you can also apply for financial support to cover some of the training and integration costs for these new staff

Who can apply?

- All businesses or organisations based in an EU country, Norway or Iceland, regardless of economic sector or size
- Any business offering a written workcontract of at least:
- 6 months for jobs or apprenticeships
- 3 months for traineeships.
- Any business/organisation offering a placement that is compliant with national law.

Where can your business recruit?

In any EU country, Iceland or Norway


