- 9 provinces
- Approx. 84.000 km²
- 9 million inhabitants
- Official language is GERMAN



Fun facts Austria

- Almost half (47.9 %) of Austria is covered by forests.
- 62 % of Austria is covered by the Austrian Alps.
- There are over 695 mountain peaks that are higher than 3.000 meters
- Austria has a total of 103 preserved castles and 368 ruins.
- Austria shares borders with 8 other countries:
 - Germany / Czech Republic / Slovakia / Hungary / Slovenia / Italy / Switzerland/ and Liechtenstein

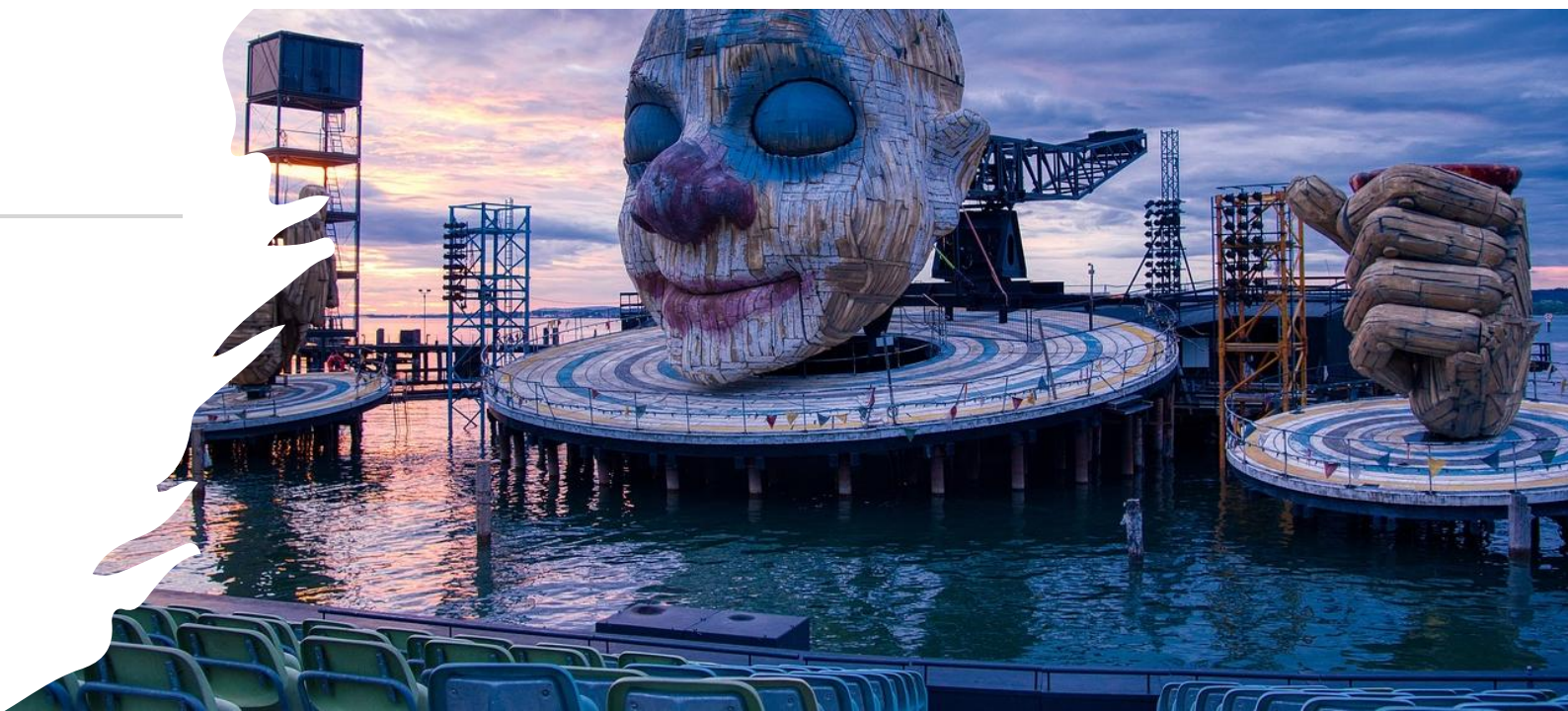

 - Overpayment is a question of negotiation

How to apply

- CV (with picture)
- Letter of application/motivation?
- Certificates?
- 2 pages
- Last things first



Working conditions (tourism)

- Fulltime job (according to Austrian law)
 - 8 hours per day in total
 - 5 days a week
 - 40 hours per week
- Overtime can be agreed up to a maximum of 48 hours per week
 - 50% extra
- Social insurances included
 - Health insurance
 - Accident insurance
 - Pension insurance
 - Unemployment insurance



Internships: WHO can apply

- Requirements
 - You are at least 18 years old
 - You are a student in a tourism school
 - Some German language skills
- Periods and minimum duration
 - 6 weeks up to 3 months
 - Summer season = from June to September
 - Winter season = from December to March

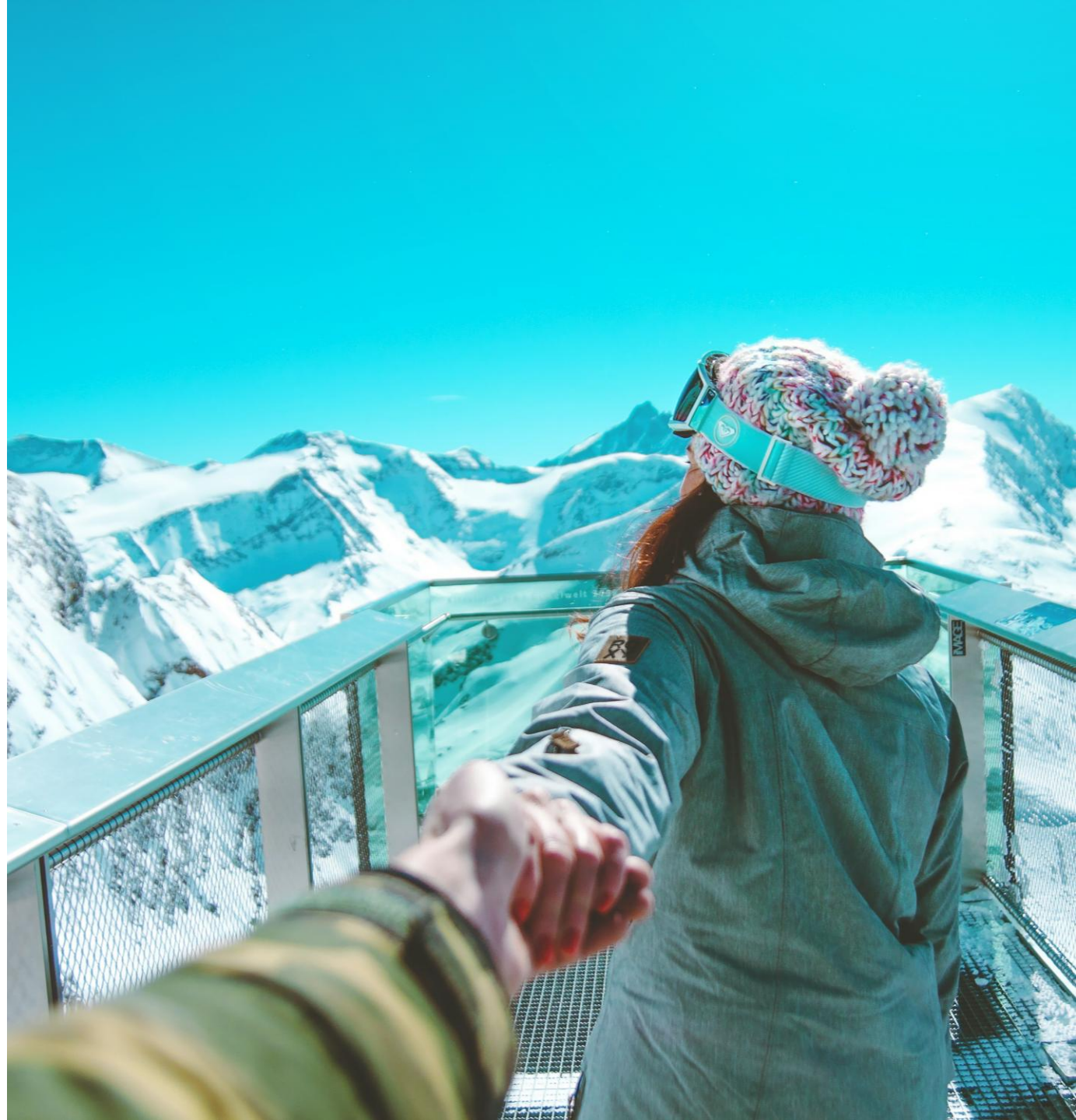

- Opportunity of a permanent position

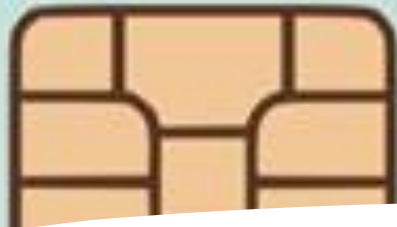


Seasonal work – important to know

Work Contracts

- Contract in written form
- Salary based on a collective wage agreements
- Monthly income 14 times a year
- Holidays 5 weeks a year
- Health, accident, pension & unemployment insurance



Taxes in Austria

EUROPEAN

- Income Tax
 - Taxes are being deducted automatically from your wages
 - Progressive Tax System
 - Yearly wages until EUR 12.816 = 0%, from 12.816 to 20.818 = 20%, from 20.818 to 34.513 = 30%, from 34.513 to 66.612 40%, from 66.612 to 99.266 48%...
- Tax equalization
 - Online via finanzonline.bmf.gv.at
