• At constant labour market participation, the labour force potential in Germany will decrease by up to 6.5 million people by 2025.

- recruiting by German companies will become more international
- particularly due to the EU's freedom of movement, employees will look for jobs all throughout the EU

Trend 4: The information and knowledge society is developing rapidly


Trend 5: Opportunities of participation are distributed increasingly unequally

Trend 6: Public finance remains scarce



The German labour market

- Germany has one of the lowest unemployment rates among EU
- One of the lowest unemployment rates (3.6%) among EU (8,9%)
- For young people between the ages of 15 and 25, Germany has the lowest unemployment rate: 6.5% in January 2017 (EU average: 17.7%)
- Dual vocational training is believed to be the main success factor in the German labour market




