## DENTISTRY IN THE NETHERLANDS

### 1. INITIAL INTERVIEW WITH AMPLIA

## 2. BIG REGISTRATION

The BIG Register - maintained by the CIBG on behalf of the Dutch Ministry of Health, Welfare and Sport, requires candidates to produce the following documents in order to accept their application:

- . Dentistry diploma (certified and translated into Dutch);
- . character reference and declaration of conformity according to EU directives, issued by your local Dentistry Council (both certified and translated into Dutch);
- . an English version of your CV;
- . a B2+ level certificate in Dutch.

*This registration process is entirely conducted by our local team in The Netherlands. As soon as you obtain you language certificate, you'll immediately start performing as a dentist.*

## 4. RELOCATION TO THE NETHERLANDS

Our local team will provide assistance with negotiating your salary package and securing the 30% tax free exemption. We promote a balance between the candidates' expectations and the needs of the prospective employers. Therefore, you'll be in control of the process with regards to future workplace - we'll work to safeguard your chance of having a choice between several clinics. In searching for accommodation, you'll also have our team's support, as well as for all the other matters related to the relocation (opening up a bank account, etc.).

## 3. DUTCH LANGUAGE COURSE

### UP TO THE B1+ LEVEL

Online learning stage, predicated in synchronous classes. This part of the course is expected to take from 4 to 5 months, with daily 3-hour sessions, from Monday to Friday - **250 hours, in total** (15 hours per week, 60 hours per month, taught exclusively by native Dutch teachers). You can schedule it around your work week, but you should set aside at least 10 hours per week for studying. We have classes starting in March and October.

### FROM B1 TO THE B2+ LEVEL

Intensive training stage in the Netherlands, going from the previously acquired B1 level up to a B2+ level, in which you'll be consolidating your skills and preparing for the final exam. This stage of the course is expected to take about 2 months to complete, with daily 4-hour sessions, from Monday to Friday, complemented by 4 hours of self-study. The course will take place at a certified language school and will be taught by local Dutch teachers. Your time will be fully allocated to preparing for the B2 exam.

## THE OFFER

- . You'll be offered a fixed-salary, full-time work contract, which usually will have you working anywhere from 32 to 40 hours per week.
- . In your first year you'll have a €3500 to €4500 net monthly salary (considering the 30% tax free rule).
- . From your first year onwards, your monthly salary should exceed €4500 net per month (again, considering the 30% tax free exemption), a figure that will be renegotiated annually.

**ESTIMATED MONTHLY EARNINGS AFTER 2 YEARS OF ACTIVITY:** it's expected that you'll exceed €6000 gross in monthly wages (the average for a general dentist will be around €6000 and €8000 per month, gross). For an **Orthodontics\*** specialist, we predic daily earnings in the €500 to €750 range, which would result in a monthly salary of around €10500/€15750 gross (between €7450 and €10700 net, considering the 30% tax free rule).

\*You'll 4 years of Orthodontics training, which clinics usually facilitate, both in terms of schedule and sometimes even costs.

### COSTS WITH THE PROCESS

B1+ ONLINE DUTCH COURSE: €3400 (VAT included), to be paid in full to Amplia before the start of the course.

B2+ DUTCH COURSE: €4000, to be paid to our partners in The Netherlands (language course + accommodation and stipend, with the **possibility of taking it as a loan\***).

B2+ EXAM: around €500, to be paid to our partner in the Netherlands.

**\*TRAINING AGREEMENT:** you'd take a sum similar to the full investment in the process, that you'd start paying back from your 2nd month of practice onwards.
