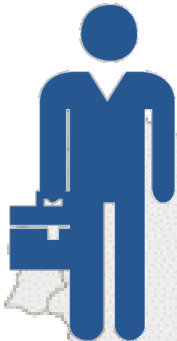

Who can benefit?

jobseekers or job changers
employers

- jobseekers or job changers aged 18+
 - EU nationals + Norway and Iceland
 - living in an EU country, Norway and Iceland
 - moving to another EU country for a job, traineeship or apprenticeship
 - legally established SMEs (with a maximum of 250 employees) of the EU countries, Norway and Iceland
 - offering employment / apprenticeships for min. 6 months or traineeship for min. 3 months
- IF...
- minimum 6 months if **job offers** or **apprenticeship**
 - minimum 3 months if **traineeships**
 - any qualification level





Financial support jobseekers or job changers

- **Interview trip** between 100€ and 350€ for the travel (depending on distance travelled) + DSA 50€/day (max. 5 days)
- **Relocation** costs between 700€ and 1.400€ (variable according to destination country)
- **Language training** reimbursement of actual declared costs up to 2.000€
- **Recognition of qualifications** flat rate 400€
- **Supplementary** relocation: flat rate 500€
- **Family support** flat rate max 1.000€/family, 350€/family member
- **Only Traineeships: Subsistence allowance** up to 600€/month (during max. 3 months)
