What is seasonal work?

This type of visa allows entry for the purpose of a fixed-term stay to a foreign worker who is called to Italy to provide a seasonal work activity, that is, in some periods of the year and in some sectors (**tourism-hotel and agricultural sector**).

This type of visa can be requested for those who have the nationality of one of the countries indicated every year by the Prime Ministerial Decree that programs the entry flows for seasonal work: upon issuance of the authorization to work, the foreign worker can enter Italy and activate the procedure to request the residence permit for seasonal work.

What is seasonal work?

The request for employment can be made by an Italian or foreign employer regularly residing in Italy, against a worker residing abroad belonging to one of the nationalities indicated in the flow decree Applications for employment can be submitted electronically by the employer or by trade associations on behalf of their members.

It can be requested as part of the quotas established by the Prime Ministerial Decree for the planning of flows in favor of non-EU workers who have already entered Italy to provide seasonal subordinate work at least once in the previous five years.

On the basis of the three-year clearance for seasonal work, entry visas for the years following the first one are granted by the consular authority. for seasonal work.
